

CFRC Training Lease Membership Rules Left Hand Lake

Access times:

1. March 1, 2021 to October 30, 2021 from sunrise to sunset daily.
2. No simulated bird shooting (e.g. starter pistols, thunder guns, etc) on Sundays before 10 a.m.
3. **LIVE GUNNING IS STRICTLY PROHIBITED.**

General Rules: (Followed by all persons granted access through CFRC Membership)

1. Pick up after your dog and any trash you may find. Keep property clean!!!
2. Be aware of the neighbors; do not impose on them with excessive noise or abusive behavior; Also no harsh use of electric collars or hitting, striking or whipping dogs as the neighbor to the west has horses, be aware, do not startle them. We do not want complaints to police or humane society.
3. **Stay off dam with vehicles; there is some culvert damage so parking is limited to the area by the entrance.**
4. Access to Members ONLY and (1) guest, (1) time and ALL GUEST MUST SIGN WAIVER **PRIOR** TO ACCESSING THE PROPERTY. Do not invite or allow non-members on site except as defined in the guest policy.
5. Access will be granted upon membership payment, rule and property waiver sign off. A combination to the lock (if used) will be provided and may be changed from time to time; this and other information and will be communicated to the group using Google Groups email list. We need your email address to so we can add you to the group for this communication.
6. Guests using the site more than (1) time must purchase a CFRC & Left Hand lease membership for any additional access. The term "Guest" excludes immediate members of the LH Lake member's household, who are welcome to join the member.
7. If you are in the process of training and other members arrive, you **MUST** complete your work **IMMEDIATELY** (within 30 minutes) or offer other Members access to your set up. Or, if other Members want to set up differently, the member on site first **MUST** be willing to run the new setup with newly arriving members. This is a majority vote rule based on the number of Members on site at one time and their decision. Handle this like a pick up basketball game, finish what you are doing, offer access to the site, and cooperate. Members hoarding the site will be asked to cooperate or leave the group.
8. Only one set (test) up will be run at a time so all members must run the same set up. Adjustments can be made to the line for less experienced dogs. The only exception is when all on site are puppy training.
9. CFRC Training Days are scheduled for two days per month. During those training days, exclusive use of the property will be for the club-organized event; all CFRC members may participate. You may use the property after the club has left the site if time allows. These will be the 1st and 3rd Sunday of each month. Non-Left Hand Lake members must sign a liability waiver form before participating in CFRC Training Days; the single waiver is sufficient to cover subsequent CFRC Training Days throughout the season.
10. No more than 20 dogs running on the property at a time. To avoid conflict, use the Google Group calendar to communicate your intentions, scheduling on Google does not give you exclusive use of the property but advises other members that more than one user will be on the property at a certain day and time.
11. Parking is available on the southeast side by the entry inside the fence. **DO NOT** park on the county road outside of the gate or the access road to the east of the property. Do not drive or park on dam or peninsulas, you will be responsible for damage to the grounds.
12. **Members are responsible for guest and immediate family member completing a liability waiver form and submitting it PRIOR TO ACCESSING the property. ALL USERS OF THE SITE MUST SIGN A WAIVER UNLESS UNDER 18. ANYONE UNDER 18 MUST BE WITH AN IMMEDIATE FAMILY MEMBER WHO HAS SIGNED THE WAIVER. Allowing a non-Member on the site contrary to rule #4 and WITHOUT A WAIVER, your membership access to the lake will be canceled without refund.**
13. **BEWARE; this is an irrigation supply lake and levels may change from time to time. There are times when it will be too low for canine swimming; there are no guarantees of 100% swimmable waters.**
14. Do not remove any water as it is personal property and is owned by the contracted agriculture business.
15. Reporting misuse of the property, use on wrong day than membership type allows, violation of ground rules, conflict with others and issues with neighbors, please document the situation, names of witnesses time and place, license number, etc, and report it to the board within 48 hours. The board will use our policies to follow up and investigate the matter.
16. **After training, please report the water status to LH Lake Group Members using the Google Groups email list and/or the CFRC Facebook Group.**

I agree to abide by these rules and agree any continued disregard of these rules can cause my membership to be CANCELED WITHOUT REFUND.

As part of this membership agreement, you will be asked to work a minimum of 1 day or combined hours totaling 8 hours at a CFRC sponsored Hunt Tests.

\$30.00 Fee for Current CFRC Members. LHL Membership allows access to Left Hand Lake 7 days per week, with the understanding that two Sundays (1st and 3rd Sunday each month) may be scheduled for Club-sponsored training days. For non-CFRC members, complete the additional CFRC Membership Form and include additional \$30 annual CFRC dues (Total: \$60).

Club Days CFRC Membership, no additional fee for 2021, access 1st and 3rd Sunday of each month on Club Sponsored and Organized Training Days. With a 20 dog limit, this day may need to be split into 2 sessions if attendees are greater than 20 dogs. In that event the Organizers will split the dogs up by ability and age into a morning or afternoon session. There will be two sessions will run at 8 a.m. to Noon and 1 p.m. to 4 p.m. **Prior registration for the event is suggested in order to plan for numbers of dogs & appropriate levels.**
